### May 17, 2018:

- **In-Office Deadline** for all Entries / Classes.
- Deadline to order stalls and pre-order bedding.

### May 30, 2018:

- Last day to scratch Limited Age Event classes and receive partial refund.
- Last day to scratch Spectaculars and receive full refund.

### May 31, 2018:

- Draw date for Derby Preliminaries.
- Draw date for all Spectacular Herd Work
  - Open & IO Bridle / Non Pro Bridle / Open Two Rein / Non Pro Two Rein / Non Pro Limited / Youth Bridle / Youth Limited
- Draw date for Open & Intermediate Open Bridle Spectacular Rein Work / Cow Work
  - All other spectaculars run concurrent with Horse Show classes and Rein Work / Cow Work will be drawn the day before the class starts

**REQUIRED HEALTH DOCUMENTS** – To comply with state animal health regulations, all out of state horses will require a negative Coggins (Equine Infectious Anemia) dated within **12 months (1 Year)** and a health certificate dated within 30 days. All out of state horses must have their health certificates and Coggins papers checked as you check into the show office.

**MOVE IN** - Horses may move in Friday, June 8th, starting at 8am.

### **SHOW OFFICE HOURS**

The show office will be open 8am – 5pm on move in days. The show office will open at 7am on show days and close after the last class ends.

**RV / CAMPING** – RV spaces will be first come first serve. **No reservations will be accepted.**

There are 140 RV spaces total on the facility. C Lot and Oak Tree Lot have full hook ups (water, sewer, electric) and are \$55 / night. The X Lot has electric and water only and is \$45.

**PAYMENT INFORMATION** - You will need to bring one open check or credit card to the Horse Show Office when checking in. In the event that no charges are incurred during the event, your check will be returned to you. Any practice pen charges will be added to your show tab, separate payment will no longer be taken at the practice pen.

**STALLS** - Stalls will cost \$225 and need to be ordered by May 17<sup>th</sup>. Any stalls ordered after May 17<sup>th</sup> will be assessed a \$50 late stall fee. There is no pre-bed. The stalls are 10'x10'. Because we need to order temporary stalls for this show, **there will be NO REFUNDS on stalls cancelled after May 31, 2018.** There is no guarantee we will have stalls available after May 17<sup>th</sup>. Some barns have temporary stalls. A stall list will be posted online on the NRCHA website approximately one week before move in. Please verify your stall count is correct and contact the office with any corrections. This online stall chart is not final – check the stall chart posted on the ground upon arrival.

**BEDDING** – Bedding is not included in the stall fee. If you wish to pre-order bedding to expedite move-in, please list your pre-bed on your entry form or you may contact the NRCHA office before **May 17<sup>th</sup>**. All bedding ordered upon arrival must be purchased through J & S Feeds 916-996-9179. The cost for shavings is \$10/bag. J & S does not sell pelleted bedding. A separate form of payment will be needed to pay for bedding and feed that was not pre-ordered through the NRCHA office.

**DAY FEES** – If you haul in, work out of your trailer and don't need a stall, there is a day fee of \$25 per day, per horse.

**TRAILER PARKING** – **NEW FOR 2018** – Trailers are only allowed in the barn area for the immediate loading and unloading of horses. There is **NO parking of trailers anywhere near the stalls.** You may not tack out of your trailer – even if you have in the past. This is a **NEW Paso Robles Event Center enforced rule.**

**HAY** – Alfalfa and Timothy hay is for sale through the J & S Feeds 916-996-9179. You may bring in outside hay. Prices are TBD.

**PRACTICE PEN** – A schedule will be posted at the show. It will be run as a Priority Works pen the same day the class shows. Other works can be worked in after the priority works for that set have completed. You will no longer need separate payment for the practice pen.

**OPEN ARENA TIME** – The show arena will have open riding time when classes have ended for the day. The arena will be open all night with controlled practice, closing at 6am for preparation for classes that day. A schedule will be posted at the show. This is subject to change based on arena prep needed.

**ENTRY INFORMATION** – All entries, stalls and pre-bed reservations are due **May 17, 2018**. All entries must be paid in full to be included in the draw. **This is an in-office deadline.** You can mail, fax or email your completed entries to the NRCHA office. We will not process your entry without a form of payment! You have several options for payment:

- You may include a check with your entry form for the full amount.
- You may include credit card information for us to charge your card. Please be aware that there is a 3.5% processing fee on credit cards. You **MUST** include all information requested in order for us to process your card.
- You may include credit card information to process your entry but then replace that with a check once you arrive at the grounds. Please be aware that if you scratch your entry, we reserve the right to charge your card for any fees due.

An entry verification list will be posted on the NRCHA website approximately one week before the draw. Please be sure to check your entries.

**LATE FEES** - Late fees will be charged to any entry received after the due date. Late fees are not charged to add classes or divisions to the original entry that was on time, for that horse.

**DRAW DATE** – The draw date for the NRCHA Derby prelims, Open & Intermediate Open Bridle Spectacular (all goes) and herd work for the Non Pro Bridle Spectacular, Open Two Rein Spectacular, Non Pro Two Rein Spectacular, Non Pro Limited Spectacular, Youth Bridle Spectacular and Youth Limited Spectacular will be **May 31, 2018**. Horse Show classes are drawn after noon the day before the class shows.

**DOGS** – Dogs are welcome at the Paso Robles Event Center.

**SIGNS, POSTERS & FLIERS** - No tape may be used on painted surfaces. Please use the non-stick command strips or sticky tack that does not damage walls. Thumb tacks are acceptable. Do not post to walls or doors in the facility!

**VIDEO:** Immediately following your run, you are able to view your run on the replay monitor at no charge. This will be a monitor set up under the announcer's booth in the warm up arena. Owners and riders may also visit Equine Promotion's booth at any time to watch video of the run at no charge. If you wish to watch a run of another horse that you do not own or are not the rider, there will be a small charge to do so. Equine Promotion's booth is located in the BarnMaster Barn. Videos may be purchased and available to you via YouTube, a USB drive and/or downloaded to your mobile device.

**PHOTOS:** Award photos will be taken in the arena. Primo Morales's booth is located in the BarnMaster Barn. You are welcome to bring your awards as well as friends and family for group photos. 5% of photo sales from the horse show are kicked back to the NRCHA Youth Association.

This event falls under the California Equine Medication Rules as authorized by state law (Food and Agricultural Code Sections 24000-24018). Participants of such event have the responsibility to ensure full compliance with the medication rules. Specifically, horses administered a therapeutic prohibited substance shall be withdrawn from competition for 24 hours after administration. Horses administered non-therapeutic substances must be withdrawn from competition until the substance has cleared the system. Therapeutic administration of one of the nine permissible substances is permitted before and during competition provided the detected level in the sample does not exceed the maximum permissible levels. Additionally, injectable substance shall not be given to a horse within 12 hours of competition. In accordance with the law, any horse on the show grounds is subject to sample collection by representatives of the California Equine Medication Monitoring Program. When an EMMP approved veterinarian is assigned to the event, the sample collected will be blood. There is no option as to the type of sample collected. Once notified it is the individual's responsibility to submit selected horse to the EMMP representative as failure to submit a selected is a violation of the law and subject the individual to a minimum fine of \$1,000. ## Limited Age Event (LAE) Rules and Guidelines

- This is a derby for 4 and 5 year olds to be shown in a snaffle or hackamore. Horses may not switch headgear within the competition. In the Non Pro Limited Derby, 6 year olds may only be shown in a snaffle.
- Open entries are automatically entered into Open divisions for which they are eligible (Intermediate Open, Limited Open). Open Money will tentatively be split 72% Open, 22% Intermediate Open, 6% Limited Open. 75% of entry fee goes to Payout.
- Level One Limited Open can be entered as its own class. Participants do NOT need to be entered in the Open, but may opt to enter the Open at a reduced fee for the level 1.
  - Entry fee to enter ONLY the Level One is \$600 – 70% of entry fee goes to Payout.
  - Entry fee if cross entering the Open entry fee to enter the Level One is \$450 in addition to the Open entry fee – 100% of entry fee goes to payout.
- The \$5K Novice Horse class will run concurrent with the Open division, but those entering the \$5K Novice Horse class do not need to enter the Open Division or Level 1, but may enter either or both if they wish. 70% of entry fee goes to Payout.
- There will be a \$330 Finals fee for those making the finals in any of the Open Divisions. Horses that make it back in multiple divisions will only pay one finals fee.
- There are no finals for Level One Ltd Open or Novice Horse.
- Non Pro entries are automatically entered into all Non Pro divisions for which they are eligible (Intermediate Non Pro and Novice Non Pro only). Non Pro Money will be paid out 65% Non Pro, 25% Int. Non Pro, 10% Nov. Non Pro. 70% of entry fee goes to Payout.
- Those entering the \$7500 Amateur Division do NOT need to be entered in the Non Pro Division. 70% of entry fee goes to Payout. 70% of entry fee goes to Payout.
- The Non Pro Limited division follows the same rules as the Horse Show Non Pro Limited eligibility (see Rule 10.4.12). 70% of entry fee goes to Payout.
- The NRCHA Rule Book contains the rules for Limited Age Events and will be followed as printed.
- Limited Age Event Refund Policy – Scratches must be made in writing and received in the NRCHA office:
  - Scratches made on or before the due date → full refund of all fees
  - Scratches made after the due date but before the draw → refund of all fees minus division appropriate entry fee retainage (25% Open / 30% Level 1 and Novice Horse and all Non Pro divisions)
  - Scratches made after the draw → video and NRCHA fees only

# Spectacular and Horse Show Rules and Guidelines

## Spectacular Information, Rules and Guidelines

- Spectacular equipment rules follow guidelines printed in the NRCHA Rulebook. Refer to Sections 3 and 5 for specific eligibility and equipment requirements.
  - Open & Int. Open Bridle / Non Pro Bridle - bridle required
  - Open Two Rein / Non Pro Two Rein – two rein required
  - Non Pro Limited – may use any age appropriate headgear (6 year olds may not be shown in a snaffle bit)
  - Youth Bridle – bridle required
  - Youth Limited – may use any age appropriate headgear
- Draw dates:
  - ALL Herd Work will be **May 31, 2018**.
  - Rein and Cow work
    - Open & Intermediate Open Bridle Spectacular – **May 31, 2018**.
    - All other spectaculars will run concurrent with the horse show classes and will be drawn the day before the class starts.
- Spectacular Refund Policy – Scratches must be made in writing and received in the NRCHA office:
  - Scratches made on or before the due date → full refund of all fees
  - Scratches made after the due date but before the draw → full refund of all fees
  - Scratches made after the draw → video and NRCHA fees only
- NRCHA Rules and Regulations will apply in all other instances.

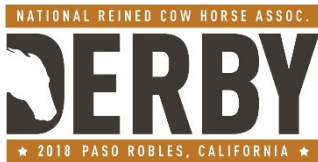
